TVEG observes the Welfare of the Horse FEI Code of conduct whereby observed mistreatment or abuse of a horse will not be tolerated and any such incidents will result in IMMEDIATE removal from the grounds.

Horse Health Declaration must be handed in at each event prior to riding. QLD riders must present tick control/movement documentation when required.

An approved EA helmet must be worn at all times whilst mounted on a horse.

Riders with horses predisposed to biting, kicking or anti social behaviour must take full responsibility for ensuring that horse is kept safe and contained and notify others of the risk if nearby to that horse.

Riders under the age of 16 years must have a parent or guardian present on the grounds at all times.

No abusive language, behaviour or interferences will be tolerated toward any person or any animal. Any such incident will result in IMMEDIATE removal from the grounds.

All members agree to respect the rights, dignity and worth of others and to be fair, considerate, kind and honest towards others. We are all here to enjoy the art of equestrian, have some fun, make friends and be happy.
